The party of the first part agrees and covenants to make an annual levy sufficient to cover the principal and interest of the road improvement bonds of Collinsville Township, in the amount and at the ration as set out above, and also to make an annual levy sufficient to pay its part of the principal and interest of the county bonded debt as the same falls due. And further agrees to have said amounts extended upon the bond records of Tulsa County so that the same may not be overlooked each year by the proper authorities whose duty it is to make tax appropriations or levies.

The party of the first part (Tulsa County) hereby assumes and agrees to pay 3/5 of the road improvement Bonded indebtedness of said detachedpart of Collinsville township, same being in the amount of \$46,000.00, issued on November 9,1915, and there remaining due and unpaid at this date the sum of \$41,000.00 in principal and \$25,920.00 of interest and to make an annual levy to cover its pro rata share of said indebtedness in the following years for the following amounts:
