

## O R D E R

An order relating to the re-assessment of the properties included in Parkview Drainage District No.2, Tulsa County, Oklahoma, in order to correct an irregularity in the proceedings through which certain lands not assessable were assessed and the assessment as a whole rendered insufficient to retire the bonds heretofore issued.

WHEREAS, There has been filed with the County Clerk of Tulsa County, Oklahoma, and presented to the Board of County Commissioners of said County, a petition signed by John M Winters, Jr., as Agent and Attorney for the holders of the bonds which have been heretofore issued for the payment of the construction expenses of the drain in said district; and

WHEREAS, the said Petition sets out that the assessment of the properties in the District is insufficient to pay the bonds by reason of irregularities in assessing property not liable to assessment; and

WHEREAS, said Petitioner requests the appointment of three resident free-holders of Tulsa County, Oklahoma, not interested in said drainage district or in the improvement therein which is alleged to have been completed which said viewers shall not be of kin to any person interested in said drainage district or of the improvement therein to view the line of improvement as completed, and the lands in the district which have been benefitted by said improvement, and to ascertain the amount of benefits of lands of the respective owner or owners, and to public and corporate roads, and railroads, and street railroads, and County, Town, School or other municipal property in said District and to re-assess the cost of said improvements thereto, and make and file their report thereof with the County Clerk in the manner and form showing the benefits to the lands and pro rata cost of such improvements to be charged against the several tracts of land and to report as to the amount of benefits received by said lands so affected, and as to the damage of such lands, and the pro rata cost of such improvements charged to the several tracts.

BE IT ORDERED by the Board of County Commissioners of Tulsa County State of Oklahoma, that R M DARNELL and CHAS P YADON and M J GLASS who are disinterested resident free-Holders of Tulsa County, State of Oklahoma, not interested in the said drainage district or in the improvements made thereon, and not of kin to any person interested therein, be and they are hereby appointed viewers to view the line of the ditch which has been constructed and completed in said Parkview Drainage District No.2., and the lands in said District which has been constructed and completed in said Parkview Drainage District No.2, and the lands in said District which have been benefitted by said improvements, and to ascertain the amount of benefits to the lands of the respective owner or owners, and to public and corporate roads, and railroads and street railroads, and County, Town, City School and other Municipal property in said District, and to re-assess the cost of such improvements thereto and to make and file their report thereof with the County Clerk showing the pro rata cost of such improvements to be charged against the several tracts of land and showing the amount of benefits received by the lands so affected and the damages to such land and the pro rata cost of such improvements to be charged to the several tracts of land which may properly be assessed in said district.

The County Clerk of said Tulsa County be and he is hereby ordered to give notice of the appointment to each of said Viewers and that said Viewers qualify and proceed in the premises as required by law.
