

The Board of County Commissioners met Tuesday June, 7th 1910, as per previous agreement. Present W.C. North, C.H. Cleveland and Geo. McKeau, absent none,

A petition for road in Sec. 29-19-14, was read and the following viewers were appointed R.B. Sandifer, J.O. Smith and A.L. Howard, together with the County Surveyor to meet July, 1910 view and lay out said road. A Petition for road in Sec. 1-19-13 was, read and the following viewers were appointed, J.D. Farr, D.L. Morgan and W.H. Chism, together with the County Surveyor to meet July, 7th 1910, to view and lay out said road.

In the matter of Erroneous assessment on lots 13rd and 14 Block 13 Berry Add. for the value of \$2500⁰⁰ same was ordered transferred to Lots 35rd and 36 same, Block.

In the matter of Road Petition of Willow Springs Township in section 1 and 2, - 17-14 the same was granted and the following Viewers were appointed C.W. Lacy, H.L. Pierce and W.W. Walton, together with the County Surveyor, are to meet on July, 2nd 1910,

In the matter of Road Petition of Township Board of Try Township in Section 35 and 36, - 18-13 the same was granted and the following Viewers were appointed, J.W. S. Bowers, P.A. Toy, and H.L. Pierce, together with the County Surveyor, to meet July 6, 1910 and view and lay out said road.

The following agreement was entered into between the city of Tulsa and the Board of County Commissioners for the care of Paupers and County patients. First that the city maintain a room at the hospital, Second that they furnish a physician for cases, inside in the city limits, Third that they furnish superintendant at the Rest house, and fumigate same, at their expense. The county to furnish all other attention supplies and Groceries,

In the matter of Road Petition of Board of Try Township for road leading east from the Jenkel Bridge the same was granted and the following Viewers were appointed, W.H. Routh, P.C. Toy, and G.G. White, together with County Surveyor to meet on Friday July 1, 1910 and view and lay out said road,

In the matter of Road Petition of John Hatchet et al for road in section 6-20-13 the same was granted and the following Viewers appointed Harry Hatch, M.C. Hale and F.S. Jones, together with the County surveyor to meet July 8th 1910 and view and lay out said road.
