Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, that the report filed by Water Improvement District No. 10 of the Cash Receipts and Disbursements from April 1, 1948 to March 31, 1949, be and the same is hereby accepted and ordered filed.
