That no other protests, objections, complaint or grievance of any kind or character was filed or presented; that upon due consideration thereof, the Board finds and holds that the above numbered alleged protests and complaints, to-wit:

do not set forth nor embody sufficient facts or merit to constitute, under the law, a valid protest, objection or complaint and should be and are hereby overruled and denied; that the application

to correct error in right-of-way description, as stated, is by counsel consented to and in open Board meeting immediately made under the direction and with the approval of said Board, by interlineation and correction of said viewers report so as to make it speak the truth and facts and thereupon its application or protest was, upon leave of the Board, withdrawn.

Upon consideration of the pretended objection and exception filed herein by L. L. King, right-of-way Supervisor on behalf of Southwestern Bell Telephone Co., this Board finds and holds that such objection is based upon a self-serving statement of assumed fact which does not exist, and, therefore, the same has no standing in this record and should be and is hereby ordered striken and expunged from this record which is accordingly done.

That upon consideration of protest No. 10 filed by St. Louis-San Francisco Ry. Co., this Board finds that said protestant has offered and consented to an amicable adjustment of its protest in substance as follows: That upon condition that viewers report be modified and corrected so that the total assessment to be levied against its property, including the property described as formerly owned by American Tank Car Company, but now owned by protestant, be fixed at \$5,000.00, instead of at \$6,783.68 as stated in said viewers report and that said amount be apportioned - \$200.00 assessed against American Tank Car Company and \$4,800.00 assessed against St. Louis-San Francisco Ry. Company, that then in such event protestant would permit withdrawal of its protest. Thereupon after due consideration and consultation with viewers, engineer and counsel, this Board deems advisable and therefore finds and holds that such offer and proposal be and same is hereby accepted and such modification and correction of viewers report fixing protestant's total assessment as stated at \$5,000.00 is hereby authorized and ordered and by interlineation immediately made and protestants' protest is accordingly withdrawn.

Thereupon, having thus acted upon and disposed of such protests and complaints, the Board accepted and approved by resolution adopted and filed, the easement and right-of-way executed by Mid-Continent Petroleum Corporation of Tulsa, and, thereupon, Texas Refining Company by Hon. Jno. R. Ramsey, counsel, moved the Board that Texas Refining Company of Tulsa be accorded the same rights and privileges granted Mid-Continent Petroleum Corporation by such resolution inasfar as applicable, to which this Board assents; that no exceptions were taken by anyone to such findings and holdings of the Board in passing upon and disposing of such protests, objections, complaints or grievances nor to the correctsions or changes in said viewers report nor any appeal prayed, asked for or granted.

The Board further finds and holds that said viewers report and the maps and drawing filed therewith as part thereof specifically defines, describes and show the lots, lands and boundary lines of said Drainage District as follows:
