

not exceed \$5.00 per day in any instance.

FOURTH: That upon the completion of the work hereinbefore set forth that the said Secretary of the County Election Board shall file all records, as required by law, and that the secretary of the Election Board shall have a sufficient number of copies of said registration made as provided for in the above, that a copy of all the registrations and Master Book and in the precinct registration shall be kept in the office of the Secretary of County Election Board for further and future reference.

FIFTH: That the secretary of the County Election Board is herein authorized to call upon the county registrar for all precinct duplicate copies of registration books now in his possession and not in the possession of the Secretary of the County Election Board and ask that they be furnished to him, the secretary of the Election Board at the earliest possible date.

SIXTH: That this order, or authorization made by the Board of County Commissioners of Tulsa County, State of Oklahoma, has been made as an emergency and for the relief of the election machinery of Tulsa County.

All members voting in favor of the order, the same was by the chairman declared carried.
