North of SE corner of SW/4 of NW/4 of Sec. 4; thence east to the West line of SE/4 of NE/4 of Sec. 4; thence south to the south right of way line of the M-K-T Railway; thence easterly along the south right-of-way line of said railway to a point 180 feet west of the north and south center line of Section 3, Township 19 North, Range 12 East; thence south to the north line of West Archer Place extended; thence east along north line of West Archer Place extended to the North and South center line of Section 3; thence east along the north line of West Archer Place a distance of 660 feet more or less, to the East line of SW/4 of the SW/4 of the NE/4 of Section 3; thence south to the East and West center line of Section 3; thence East to the Northeast corner of the NW/4 of the SE/4 of Section 3; thence southeast to the SE corner of Lot 7, Section 2, Township 19, Range 12 East; thence south to the point of beginning, containing 2,713.7 acres, more or less.

SOUTH SIDE OF ARKANSAS RIVER

"Beginning at the southwest corner of the southeast quarter of the southwest quarter of the southeast quarter of Section 8; thence running easterly along the south line of Sections 8 and 9, to the southwest corner of the southeast quarter of the southeast quarter of Section 9; thence southeasterly to the southwest corner of the northwest quarter of the northwest quarter of Section 15; thence southeasterly to the southwest corner of the southeast quarter of the southeast quarter of Section 15; thence southeasterly to the southwest corner of the northwest quarter of Section 23; thence easterly along the center lines of Sections 23 and 24, to the intersection of said center line with the right hand meander line of the Arkansas River; thence northwesterly and southwesterly along the said right meander line to the intersection of said line and a line running parallel with and 1980 feet west of the East line of Section 8; thence southerly to the point of beginning; containing 2700 acres, more or less."

That the proposed improvements recommended by said Viewers reads:

" That the kind and character of improvements proposed by petitioners and recommended by the survey of the U.S. Government, consists of a completed and connected system of strong and enlarged levees, together with all necessary culverts, drains, ditches, bridges, flood-gates, pumping stations, diversion channels and other necessary appurtenances and kindred and incidental work to control the flood waters of such area and prevent the injury and damage which would otherwise result".

Thereupon again comes counsel for said Board and Drainage District and offered additional oral evidence in support of said petition and amendment and also in support of said viewers report as corrected and had sworn as witnesses:

Each of whom then and there testified before said Board that the creation and establishment of such Drainage and Improvement District as prayed for for the reasons and purposes alleged, and the building and finishing of the improvements therein as stated in said petition and recommended by said viewers report is a public necessity and when finished and completed as proposed and planned would be of great public utility, benefit and advantage to public health, property values and agricultural lands.

NOW, THEREFORE, it is by this Board hereby Resolved and Ordered that said Petition and amendment are in form and substance, as required by law, and the prayer thereof is hereby sustained and granted and the proposed Drainage and Improvement District sought and prayed for and as described above is hereby created and established and named and designated:

TULSA COUNTY DRAINAGE DISTRICT NO. 12.,

and it is by this Board further resolved and ordered that the viewers report filed herein August 2nd, 1943, is in all respects as required by law, and is now hereby ratified, confirmed and approved as modified and corrected as hereinabove authorized and it is by this Board further resolved and Ordered that the proposed improvements sought to be constructed and completed in said District as prayed for in the petition and recommended and described in said viewers report, be and the same are hereby authorized and directed to be constructed, in accord with the proposed plan of aid and co-operation between the United States Government and Tulsa County Drainage District No. 12, as alleged and prayed for in the petition as amended and in the Resolution of co-operation adopted and filed herein on May 3rd, 1943.

IT IS FURTHER RESOLVED AND ORDERED by this Board that the schedule of lots and lands and of corporate roads and railroads, corporations, firms and companies subject to assessment in said District with descriptions and names of owners and the pro-rata amount of assessment taxed and levied against each as returned and recommended by said viewers report is hereby approved, ratified and confirmed, and that each and all of the respective amounts specified and set opposite the description of such lots and lands described with the name of the owner or party in control thereof insofar as could be ascertained by such viewers but whether correct or not in naming the true owner of such lots or lands, the levy and assessment in the sums and amounts named herein are hereby levied, assessed and imposed to run against each lot or tract of land whoever may be the owner as described and set out in said viewers report for the purposes named and are each and all hereby impressed by operation of law with a lien as provided by law on each of such lots or tracts to secure the payment of the respective amounts assessed and levied against each, and that each of such amounts shall bear six percent (6%) interest per annum from and after the 1st day of
