

MONDAY, JULY 2nd, 1945
10:30 o'clock A.M.

The Board of County Commissioners met in the office of the County Clerk of Tulsa County, State of Oklahoma, at the hour of 10:30 o'clock A. M., for the purpose of organizing the new Board of County Commissioners. The new members, to-wit: J. B. Gray, Curtis Greer and Claude W. Bailey were sworn in by James P. Melone, Judge of the County Court of Tulsa County, State of Oklahoma. All members being qualified as required by law.

The first business coming on for consideration of the Board was the appointment of a Chairman.

Motion made by Commissioner Greer, seconded by Commissioner Bailey that J. B. Gray be appointed Chairman of the Board of County Commissioners for the next term. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

J. B. Gray, Chairman presiding, the following business was transacted.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the bond of Joe T. Parkinson, County Treasurer of Tulsa County, Oklahoma, for the term beginning July 2, 1945, be fixed in the sum of One Hundred Thousand (\$100,000.00) Dollars, same to run to the State of Oklahoma. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the bond filed by Joe T. Parkinson, County Treasurer, in the amount of \$100,000.00 and made by the Maryland Casualty Company, be and the same is hereby approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Bailey, seconded by Commissioner Greer, that the appointment of deputies in the County Treasurer's office for the term Beginning July 2, 1945, be confirmed and their salaries and bonds be fixed as follows:
