Parkinson, County Treasurer of Tulsa County, Oklahoma, for the term beginning July 2, 1945, be fixed in the sum of One Hundred Thousand (\$100,000.00) Dollars, same to run to the State of Oklahoma. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the bond filed by <u>Joe T. Parkinson</u>, County Treasurer, in the amount of \$100,000.00 and made by the Maryland Casualty Company, be and the same is hereby approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Bailey, seconded by Commissioner Greer, that the appointment of deputies in the County Treasurer's office for the term Beginning July 2, 1945, be confirmed and their salaries and bonds be fixed as follows:
