

COMMISSIONERS JOURNAL, TULSA COUNTY, OKLA.

Tuesday, January 4th., 1916.

The Board of County Commissioners of Tulsa County, met in their rooms at the County Court House in Tulsa, on January 4th., 1916, Tuesday, in adjourned session. Present: C. S. Avery Chairman, A. W. Lucas, and Ed Baker, and Lewis Cline, County Clerk.

The following amounts for bills paid twice, were collected by O. O. Pryor, who has the contract for such collection:

Total, \$211.36, and a warrant was issued to O. O. Pryor for the amount of \$105.68, in payment for said collection.

A written notice was received by the said Board from Jno R. Moody, notifying them that the roadway now being used along Lots one (1) and Three (3) in Section 33, Township 20 North, Range 12 East, being the boundary line of Osage and Tulsa Counties, would be closed up, on February 1st., unless work had been done on the Right of Way of said Road before said time.

It appearing to the satisfaction of the Board that heretofore, to-wit: on the 30th., day of December, 1915, there was made and entered in the District Court in and for said County and state an order suspending James Woolley, Sheriff of Tulsa County, from the further performance of the functions of his office, during the pendency and determination of a written accusation returned by the Grand Jury of said County, and that by virtue of said order the office of Sheriff is now temporarily vacant; and it further appearing to the satisfaction of the Board that under Article 4 of Chapter 62 of the Harris-Day Code, this Board has the power and authority to temporarily fill said vacancy and it is incumbent upon said Board to do so;

It was thereupon moved, seconded, unanimously carried and ordered by this Board that James W. Patton a legally qualified citizen and resident of Tulsa County, Oklahoma, be and he is hereby appointed Sheriff of Tulsa County, Oklahoma, temporarily, with full power and authority to discharge all the functions and duties of said office pending the final hearing and determination of the accusation returned by the Grand Jury against James Woolley, Sheriff, and that his official Bond be and the same is hereby fixed at Ten Thousand Dollars, (\$10,000.00).

The Bond of James W. Patton, in the amount of \$10,000.00 with H. C. Tyrell, J. B. Wilson, and J. A. Hull as sureties, was filed and approved.
