WHEREAS, the Board of County Commissioners on the 21st day of January, 1929, in meeting regularly convened so that date, adopted a resolution authorizing the introduction of a bill in the legislature of the State of Oklahoma, by the terms of which proposed legislative Bill, the Board of County Commissioners of Tulsa County, Oklahoma, would be authorized to give, donate and convey by proper and legal conveyance to the Tulsa County Humane Society a corporation of Tulsa, Oklahoma, the following described real estate and improvements thereon and appurtenances thereunto appertaining, situated in Tulsa County, Oklahoma, to-wit;

Lots One (1), Two (2) and Three (3) in Block Twenty (20) Orcutt Addition to the City of Tulsa, Oklahoma, as shown by the recorded plat thereof, and

WHEREAS, due and proper notice of the intention to introduce such proposed bill in the legislature was given by publication in the manner provided by the constitution of the State of Oklahoma, in such cases made and provided; and

WHEREAS, pursuant to said resolution and saidpublished notice, there was intorduced in the legislature of the State of Oklahoma a bill known as Senate Bill No. 192, entitled "AN ACT PERMITTING AND AUTHORIZING THE BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY TO GIVE, DONATE, GRANT AND CONVEY CERTAIN REAL ESTATE TO TUISA COUNTY HUMANE SOCIETY, a CORPORATION of Tulsa, Oklahoma, REPEALING ALL ACTS IN CONFLICT THEREWITH, AND DECLARING AN EMERGENCY"; which bill was fully passed by both houses of the legislature as an emergency measure and was duly approved on the 14th day of March, 1929, by W.J.Holloway as acting Governor of the State of Oklahoma; and

WHEREAS, pursuant to the authority vested in the Board of County Commissioner s under and by virtue of said Senate Bill No. 192, the Board of County Commissioners of Tulsa County, Oklahoma, desire to give, donate, grant, transfer and convey by proper and legal conveyance to Tulsa County Humane Society of Tulsa, Oklahoma, all of the interest of the Board of County Commissioners of Tulsa County, Oklahoma, and of the County of Tulsa and State of Oklahoma, owned by them, of either of them in and to the above described real estate with improvements and appurtenances thereon and thereunto appertaining.

BE IT THEREFORE RESOLVED by the Board of County Commissioners of Tulsa County, Oklahoma, in meeting regularly convened, that the above described lands and tenements, with all improvements thereon and appurtenances thereunto appertaining be given, donated, transferred and conveyed by proper and legal conveyance to said Tulsa County Humane Society, and the Chairman of the Board of County Commissioners of Tulsa County, Oklahoma, be and he hereby is authorized to execute a proper and legal conveyance of said premises and property to said Tulsa County Humane Society, which conveyance shall be attested by the County Clerk of Tulsa County, Oklahoma, with the seal of said Tulsa County, Oklahoma, affixed thereto, and shall convey all of the right, title, interest, estate and equity of Tulsa County, Oklahoma, and the Board of County Commissioners of Tulsa County, Oklahoma, in and to said lands, tenements, improvements and appurtenances above described, to said Tulsa County Humane Society, as a gift and donation, and without consideration, and without receiving anything of value therefor from said Tulsa County Humane Society; and upon the due and proper execution of said conveyance, the same shall be delivered to said Tulsa County Humane Society.
