of October, 1943, until paid, subject to the right and privilege of paying the whole of such sum so levied or the whole of any such sums separately taxed or levied against one or more tracts at any time without interest on or before the 1st day of October, 1943; that such sums not exceeding ten (10) until fully paid and to be paid at the same time and place as other state and County taxes are due and as payable and shall become delinquent and hear the same rate of interest and penalty as other delinquent taxes if not so paid when due.

To Is further resolved and ordered by the Board that the County Clerk of Tulsa county, being ex-officio Clerk of this Board, be and is hereby ordered and directed to immediately enter, copy and spread upon the records of his office, known as the "Drainage Assessment Book", as required by law, the schedule of lots and lands and properties in said amounts levied and assessed against each as are set forth in the Viewers report filed herein and this day ratified and confirmed by this Board, and immediately certify same to the County improvement project or until the term of such assessments and payments are fully paid and as lots and lands, descriptions and names upon such "DRAINAGE ASSESSMENT BOOK", and certify same to the County Treasurer so that such annual assessment, collections and payments may proceed in an orderly manner as contemplated until such project is finally completed.

AND IT IS FURTHER ORDERED AND DIRECTED by the Board that said County Clerk fix a day certain not later than October 1st, 1943, and give notice by publication, as provided by law, once each week for two successive weeks in some newspaper of general circulation published in Tulsa County directed "TO WHOM IT MAY CONCERN" notifying and granting all owners of property assessed in said District, the right and privilege to pay such assessment so levied upon his lands or any parcel thereof separately taxed on or before the date as fixed, on which date or as soon thereafter as may be convenient, this Board will authorize and cause to be issued Drainage Bonds of Tulsa County as petitioned and prayed for and as recommended on behalf of said Tulsa County Drainage District No. 12 to pay said Districts' pro-rata share for such improvement.

IT IS FURTHER RESOLVED, ORDERED AND DECREED that the Resolutions, findings and orders made and passed by this Board on January 9th, 1943, approving the petition authorizing the creation of proposed district and designating a name and number therefor, the order approving cost bond, the Resolution and Order appointing first set of viewers and the order approving form, contents and regularity of their Oath taken and filed their report as such viewers, both in form and contents as filed on January 20th, 1943, the order approving notice of hearing on petition and viewers report, proof of publication therefor and resolution and orders approving same, the actual hearing on said petition and viewers report on February 15th, 1943, orders overruling protests filed thereto and Resolution and Order of Confirmation of approval of both petition and viewers report, both in form and substance, the entire records, resolutions, findings, orders and proceedings before this Board and in the District Court in the matter of selecting, appointing and qualifying the Second Set of viewers herein, W. O. Dickenson, C. J. Rush and Robt. G. Fry are each and all now hereby generally and specifically reappointed re-approved, re-ratified and re-confirmed as of the day and date originally made and entered and also as of this date, and in the event any part, paragraph or section of this entire record should for any reason be held irregular or invalid such holding shall in no way affect the remaining portion thereof.

Thereupon, Commissioner Greer moved the adoption of each and all of the Resolution, Findings, Orders, Decrees and Proceedings of approval, ratification and confirmation herein above set forth and same being seconded by Commissioner Kinkaid, and on a roll call for vote of members being had thereon, resulted as follows
