

of the state of Oklahoma, to the amount of \$75,000, for the purpose of providing the necessary funds for the construction of bridges in and for said county, prescribing the form of said bonds and of the interest coupons to be thereto attached, providing for the levy of an annual tax sufficient to pay the interest on said bonds when due, and to constitute and maintain a sinking fund for the discharge of the principal thereof at maturity, and fixing the other details of the issue", and

Whereas, said resolution provided that said bonds should bear date as of the first day of December, 1909,

Whereas, the issuance of said bonds has been delayed until the present time because of legal complications, said bonds just now being ready for execution and issuance, and

Whereas, it is deemed for the best interest of the County of Tulsa to have said bonds bear date as of the first day of June, 1910 instead of the first day of December, 1909.

Now, Therefore, Be It Resolved By The Board Of County Commissioners, of Tulsa County, State Of Oklahoma,

That said resolution, passed on the 16th day of November, 1909, be, and the same is, hereby amended in that the bonds authorized to be issued thereon shall bear date as of the first day of June 1910, and not the first day of December, 1909, as therein provided; that each of said bonds shall mature and become due six months later than provided for in said resolution; that all other provisions of said resolution shall remain in full force and effect.
