Monday, January 17th., 1916.

The Board of County Commissioners, met in their rooms at the County Court House at Tulsa, Oklahoma, on Monday, January 17th., 1916 at 9 o'clock A. M.in adjourned Session. Present C. S. Avery, Chairman, A. W. Lucas, and Lewis Cline, County Clerk. Absent: Ed Baker.

The following bids were opened for the Digging of the Fry Drainage Ditch, between Sections One (1) and two (2) in Township Seventeen (17) North, Range Thirteen (13) East:-

Frank Trussler bid 14 cents per yard, for digging ditch and removing dirt to the center of the road, no overhaul included.

J. H. Shellenbarger, bid 20 cents per yard.

Kelly F. Gibson construction company bid $14\frac{1}{2}$ cents per cubic yard, and furnish all machinery and complete same.

- C. G. White bid 12 cents per yard, according to specifications.
- J. O. Coatney bid 17 cents per cubic yard.
- A. J. Ketchum bid 14 cents per cubic yard for all slip work; for dirt over 100 feet to be done by force account, plus 10% for profit.
- E. F. & J. W. Lonsdale, bid 15 cents per cubic yard.
- C. G. White submitting the lowest bid. A motion was made by A. W. Lucas and seconded by C. S. Avery that the letting of said contract be postponed until Monday, February 7th., 1916 at the regular meeting. Motion carried.

The Opinion of the County Attorney, as to the powers of the County Commissioners of adding to or subtracting from the Tax rolls was submitted, said opinion was to the effect that the County Commissioners' jurisdiction was limited and they were only allowed to correct said tax rolls wherein there had been a double assessment or property had been destroyed by floods, fire or otherwise.
