O R D E R

Now, On this 25th. day of October. 1926, the matter of the Petition of the Oklahoma Natural Gas Corporation for permission to lay a pipe line along, under and across certain highways in said County and State came up before the Board of County Commissioners of said County for hearing, and it appearing to the Board and each of the Commissioners thereof that it was just that the said Oklahoma Natural Gas Corporation be permitted to use as much of the highways as designated by blue print map of survey attached to Petition of said Corporation, and according to said description, which is as follows, to-wit:

Beginning at a point in the Southeast Corner of Section 27, Township 20 North, Range 13 East, and running thence South to a point on the North side of Admiral Place (paved road) being 641 feet South of the North line of Section 3, Township 19 North, Range 13 East; thereby paralleling the North and South Section line highway, within said highway as shown on blue print map attached to Petition, between Secs. 34 & 35, Twp. 20 N., Rge. 13 East, and Sections 2 & 3 Twp. 19 N., Rge. 13 East; Also, crossing the East and West Section line highways between Sections 27 and 20, Township 20 N., Range 13, East, and Section 34, Twp. 20 N., Rge. 13 East and Section 3, Twp. 19 N., Rge. 13 East; together with any other public roads or highways which might be crossed by a gas pipe line laid in accordance with attached blue print map of survey. This line known as "Service Lines- City of Tulsa", a proposed eight inch gas pipe line.

AND, it further appearing from the petition herein that said pipe line will be so constructed as not to interfere with any of the rights of the general public in the use of said highways, and will be constructed in accordance with all rules of the County Commissioners and the laws of the State of Oklahoma governing same.
