

RESOLVED, That O G Weaver, County Clerk of Tulsa County, Oklahoma, be and he is hereby authorized and directed to correct an original resolution passed by the Board of County Commissioners at its meeting held on the 16th. day of April, 1928, calling and authorizing an election in Water Improvement District No 8, wherein the territory proposed to be included in said Water Improvement District was described, the correction being as follows:

A statement contained in the metes and bounds description of the proposed District as follows:

" thence East  $\frac{3}{4}$  mile to the SE corner of SW $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 30" be corrected in said original resolution to conform to the truth and fact of said description so as to read as follows:

"thence West  $\frac{3}{4}$  mile to the SE corner of SW $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 30"

BE IT FURTHER RESOLVED that this resolution be and become effective from and after its passage and approval.

O R D E R

WHEREAS, The Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance to EULA HAND of a deed conveying to him for a consideration of Eighteen and 69/100 (\$18.69) the following described lot:

Lot 2, Block 1, Jno. O. Mitchell re-Sub of S $\frac{1}{2}$  Blk. 1 and Block 6, Adams Addition to Tulsa.

AND, WHEREAS, the sale of said lot by the County Treasurer was made pursuant to Section 9745 of the compiled Statutes of Oklahoma of 1921, and amendments thereto, whereby the County Treasurer is authorized to sell lands and lots purchased for the County by him at tax re-sale, and

WHEREAS, due notice has been given and published by the County Treasurer in the Tulsa Daily Legal News, the official paper of the County of Tulsa, that said County Treas. would on this date apply to the Board of County Commissioners for an order approving said sale, and directing the issuance of deed therefor, and

WHEREAS, pursuant to such notice, hearing on such sale has been had by the Board of County Commissioners, and no other person having appeared to bid a higher price for the purchase of said lot, and the County of Tulsa has no need for said lot for any purpose required and provided by law whatsoever.

NOW, THEREFORE, the Board of County Commissioners of the County of Tulsa, State of Oklahoma, in regular session assembled and pursuant to the aforesaid statutes of the State of Oklahoma, hereby approve the sale of said property so made by the County Treasurer to EULA HAND for a consideration of \$18.69, and it is hereby ordered that the Chairman of the Board of County Commissioners execute to Eula Hand a deed conveying to her all the right, title and interest of the County of Tulsa, State of Oklahoma, in and to said property, and the County Clerk of Tulsa County is hereby directed to attest with his signature and attach the seal of his office.
