And the County Clerk is hereby authorized to make the transfers as above set forth.

A renewal Certificate on the Depository Bond of the Liberty National Bank of Tulsa, as Principal and the National Surety Company of New York, as surety in the amount of \$15,000.00 was filed and approved.

A motion was made by Ed Baker and seconded by A.W.Lucas that Arthur Bynum be appointed Road Overseer of Fry Township, said appointment to expire December 31st., 1916. Motion carried.

A motion was made by Ed Baker and seconded by A.W.Lucas that the County Treasurer be instructed to extend the time of the payment of taxes, without penalty, until February 15th., 1916. Motion carried.

A motion was made by A.W.Lucas and seconded by Ed Baker that the Perryman-Yeokum roadway through section Seventeen (17) Township Eighteen (18) North, Range Thirteen (13) East, be declared to stand as surveyed, a profile of such survey being now on file in the County Clerk's office, and shall be declared to be the proper road and the profile and survey of same is approved and shall not be changed, but shall be re-appraised. Motion Carried.

A motion was made by Ed Baker and seconded by A.W.Lucas that Arthur Antle John L. Smiley, and H. E. Woodard, be appointed appraisers, of the Perryman-Yeokum roadway in Section Seventeen (17) Township Eighteen (18) North, Range Thirteen (13) East; said appraisers to meet with the County Surveyor, at his convenience, and appraise the damages of said roadway.

A resolution was made and adopted, that the following date be used for a name plate, for the Arkansas River Bridge, now under erection at Tulsa:-
