The Board of County Commissioners met in their regular semi-monthly meeting at 9 o'clock, present C.S.Avery, Ed.Baker, absent A.W.Lucas:

A motion was made that the County Treasurer be ordered and instructed to furnish certificates to the abstract company or the public when requested to do so for all delinquent taxes as shown by the records. In the matter of assessments of the banks of Tulsa County, asking a rebate from the State Board of Equalization, the matter was represented by the law firm of Aby & Tucker and the county was represented by the County Attorney's office. After hearing evidence the rebate was granted, as prayed for.

In the matter of assessment of Central Park, said Central Park being represented by W.J.Gregg, and the county being represented by J.P.Evers, assistant county attorney, after the petitioners had presented all evidence a motion was made by Ed. Baker and seconded by C.S. Avery that the judgment should be held until the next regular meeting.

An order was made by the Board of County Commissioners to cancel the tax sale certificate on the NE/ $\frac{1}{4}$ -NW/ $\frac{1}{4}$ and the N $\frac{1}{2}$ of the SE-NW, and the SW-SE NW for all years and the county treasurer be instructed to refune all money erroneously certificates. paid, and the said land be divided in parts according to the present owners of same.
