MARCH 6th, 1916.

The Board of County Commissioners of Tulsa County, Oklahoma, met in their rooms in the Court House at 10:00 A.M. present Ed. Baker, and C.S. Avery, absent A. W. Lucas.

A general discussion followed on various matters.

**Claim of** In the matter of the claim filed by A.B. Cope for the injury to one gray horse A.B. Cope the amount being \$200.00 with petition accompanying same. **Resig-** The resignation of G.A. Snyder, road overseer of Jenks township, was filed and

**Petition** The petition of F.M. Kerwin of Jenks township, as road supervisor, being presented of F.M. was moved that he be appointed road supervisor to fill out the unexpired term of Kerwin, G.A. Snyder, resigned. His bond being fixed at \$500.00 with Leroy Carpentier, S.R. as road- Pitman, Paul Jennek, and Alna Phillips, and J.S. Longhorn, as sureties. overseer. Said bond being approved he was instructed to proceed with his duties as such officer.

**Hearing** The hearing of Central Park Addition coming up from the postponement of last of Central meeting, said Central Park being represented by Judge Gregg, and Tulsa County Park by J.P. Evers. It was mutually agreed that the carrying be postponed until the Addition. next regular meeting, being the first Monday in April, 1916. Motion was carried.

**Sale of** In the matter of the sale of 15 - 55/100 acres of land where the Dry  
**Land.** Farming Congress Buildings now stand and the Kaffir Corn Palace, petition was presented by N.H. Graham, secretary of the Free County Fair Association, wherein it was represented that Mr. Graham would organize a holding company to take over said tract of land and after taking it over at a nominal price, that said association would deposit with the County Commissioners of Tulsa County, Okla. 51 % of all stock issued by said corporation, to protect the county from ever losing control of said land. The intention of the corporation to finance the Tulsa County Fair Association, and to own the said buildings, using only such funds that could be used to repay the association their money back, when the corporation had received all money back paid out by them, then said corporation should turn over all stock to the Tulsa Free County Fair Association.
