A group of Members of the Chamber of Commerce, and other civic minded citizens, appeared before the Board in regard to \$4,000,000.00 bond levy to be used in the construction of a County Court House. Mr. Pat Malloy, Chairman of the Chamber of Commerce Committee, which made an extensive study of the urgent need for a new Court House, outlined the report of the Committee in full. He stated that it was the Committee's recommendation and request that Tuesday a special election be held on/September 27, 1949, in order that all qualified voters be given an opportunity to vote on this bond issue. Thereupon, motion was made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, that the Board of County Tuesday
Commissioners call a special election to he held on/September 27, 1949, for a vote on the \$4,000,000.00 Bond issue, for the construction of a new County Court House and Jail.

A Committee consisting of Mr. W. G. Skelly, Mr. Tracy Hunsecker, Mr. Robert Adams, and others met with the Board for the purpose of bringing up the matter of the Tulsa Exposition and Fair Grounds lease, requesting the Board to approve and sign the lease as drawn. After much discussion, it was decided by the Board to refer the lease to the County Attorney, Elmer Adams, for his opinion, and that the Committee meet with the Board on Thursday, June 23, 1949, regarding this Lease.
