Motion was made by Mr.North, seconded by Mr.Hedgecock, that Claim No. 116344 be and the same is hereby disallowed. Said claim filed favor of Tulsa County Public Health Association.

Motion was made hy Mr.North, seconded by Mr.Hedgecock, that the following claims be and the same are hereby allowed in the amount of \$5.00 per day. Claims numbered 116386 to 116390 inclusive, 116393 and 116498 respectively.

Motion was made by Mr.Hedgecock, seconded by Mr.Stuckey, that Wallace L Davis be and he is hereby re-instated on the Highway Patrol Force. The following vote was cast: Mr.North, Pass; Mr. Stuckey, Yes; Mr. Hedgecock, Yes. Motion receiving a majority of the votes, was declared carried.

NOW, On this 15th. day of November, 1926, the matter of the petition of Oklahoma Natural Gas Corporation for permission to lay a pipe line along, under and across certain highways in said County and State came up before the Board of County Commissioners of said County for hearing, and it appearing to the Board and each of the Commissioners thereof that it was just that the said Oklahoma Natural Gas Corporation be permitted to use as much of the highways as designated by plat filed by said corporation, and according to said description, which is as follows, to-wit:

Beginning at a point near the Southeast Corner of Section 26, Township 19 North, Range 12 East, and running thence in a North and Northwesterly direction to a point in Section 10, Township 19 North, Range 12 East; thereby crossing roads, public highways, streets and alleys, or along same, within or between Sections 26, 23, 14, 11 and 10, Township 19 North, Range 12 East, according to blue print map of survey hereto
