R E S O L U T I O N

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners that said claims in the total amount of \$9.15 be shown as claims and contracts pending in account No. 5 "Plant Operation" for Dependent Separate Schools and that the unencumbered Balance be corrected to \$44.45 making total claims and contracts pending \$402.19 and Unencumbered Balance \$406.11 with a total cash surplus available for 1945-46 in the amount of \$3888.51.
