A strip of land 25 feet in width commencing at the Northeast corner of Lot One (1), also known as the Northwest Quarter of the Northwest Quarter of Section 30, Township 19 North, Range 13 East, and continuing South a distance of 463.7 feet (as described in deed of dedication by H. and Rose Borochoff dated May 6, 1925 and recorded in Book 508 at Page 407 of the records of the County Clerk of Tulsa County, Oklahoma)

and

Commencing at the Southeast corner of mid Lot One (1), thence North on a line parallel to the West Line of said Lot One (1) a distance of 856.3 feet, thence West and parallel to the North Line of said Lot One (1) a distance of 25 feet, thence South and parallel to the West Line of said Lot One (1) a distance of 856.3 feet to a point on the South line of said Lot One (1), thence East and parallel to the North line of said Lot One (1) a distance of 25 feet to the place of beginning (as described in the Plat and Dedication of Radio Rose Assition (now vacated) filed on May 6, 1925 and recorded as Plat # 733 in the office of the County Clerk of Tulsa County, Oklahoma)

and

The East 122.96 feet of Forty-second Street, more particularly escribed as follows: commencing at a point on the North Line of Forty-second Street, which point is 25 feet West of the East Line of said Lot One (1), thence running West along the North Line of Forty-second Street a distance of 122.96 feet to a point, thence South and parallel to the East Line of said Lot One (1), a distance of 50 feet to a point on the South Line of Forty-second Street, a distance of 122.96 feet to a point 25 feet West of the East Line of Lot One (1), thence North parallel to the East Line of Lot One (1) a distance of 50 feet to the place of beginning (as described in the Plat and Dedication of Radio Rose Addition (now vacated) filed on May 6, 1925 and recorded as Plat # 733 in the office of the County Clerk of Tulsa County, Oklahoma)

And it appearing that said petitions are in all respects sufficient; that said roads have never been opened or used by the public as roads or highways; and it further appearing that due legal notice to the public has been given for twenty (20) days prior to this date of the filing of said petitions to vacate and of the date when hearing would be held and said petitions acted upon by advertisement in the Tulsa Daily Legal News, as appears from the proof of publication on file with the County Clerk; and no objections having been filed or made to the vacation of said roads and that said petitions should be granted.

NOW, THEREFORE, BE IT RESOLVED by the County Commissioners of Tulsa County, Oklahoma, sitting in regular session that the petitions to vacate said roads and highways be and the same are hereby granted; that this board hereby finds and determines that said roads have never been opened or used by the public and that a road or highway thereon is unnecessary and impractical as the area surrounding these roads is being platted into subdivisions in which plats more suitable and desirable roads will be dedicated to serve the public and the area; that the said deeds of dedication, plats and reports of commissioners taking any of said lands for highway purposed hereinabove described, to which reference is hereby made, insofar as they include the roads and highways hereinabove described be and the same hereby are vacated, set aside and held for naught the same as if they had never been made.
