FIRST: That certain appropriations heretofore made are inadequate to properly maintain the COUNTY HIGHWAY FUND of Tulsa County, Oklahoma, for the current fiscal year, and that the public welfare and needs of said county are such as to require for the remainder of said year, for legal and ordinary expenses, the additional appropriations as listed and set forth by purpose and amounts in Exhibit "A" attached, and made a prt hereof.

SECOND: That the Financial Statement hereto attached and mærked Exhibit "B" shows as of the close of the month next proceeding the filing hereof the true and correct condition of the COUNTY HIGHTAY FUND of said municipality, and the surplus of \$13,504.97 thereon shown is available for additional appropriations.

THIRD: That the appropriations as listed in Exhibit "C" hereof aggregating \$1817.85 are for purposes less urgent and imperative then the additional meds herein presented.

WHEREFORE, request is hereby made that an order be made and entered cancelling the said appropriations; and that the revenue released in the amount of \$1817.85 and said surplus of \$14,504.97 be applied and appropriated to the several additional and supplemental purposes as set forth in Exhibit "A" hereof.

WE FURTHER CERTIFY, that the aggregate amount of said proposed additional and supplemental appropriations is not in excess of the income and revenue provided and accumulated for the current year.
