Coming on for a hearing is CZ-88, Eddie Brand, Applicant, a tract located 1/3 mile north of the northwest corner of 66th St. and North Peoria Avenue. Young stated the \$50. publication fee had been paid and hearing would proceed. Mr. Steve Compton, TMAPC, was present and stated that the Planning Commission voted to recommend that the property be rezoned IL. Don Hallock, County Inspector stated that once the applicant removes the parts from automobiles that he needs for his business, he will have to dispose of the excess. An open salvage will not be allowed. The Board understands this to be use unit #17 and 25. Young asked if there was anyone present to speak in favor or against this application. There was none. Moved by Young, seconded by Harris, to approve IL zoning on the tract as described due to the Board's determination that use unit #17 which is automotive and allied activities and use unit #25 which is light manufacturing and industry as the uses proposed under this zoning application. Moved by Rice, seconded by Harris, to disallow and cancel Warrant No. 2498 in the amount of \$787.75. Upon roll call, Harris, yes; Rice, yes; Young, yes. Motion carried.

Moved by Harris, seconded by Rice, to approve and authorize execution by the Commission, the following claims provided that all claims involving wages and/or salaries be subject to state and federal withholding income tax, retirement fund, and social security deductions. (Vendor warrants will be issued on September 12, 1983.) Upon roll call, Harris, yes; Rice, yes; Young, yes. Motion carried.
