

COMMISSIONERS JOURNAL, TULSA COUNTY, OKLA.

Monday, April 3d 1916.

The Board of County Commissioners met in regular session in their rooms in the County Court House ,Monday April 3d 1916, at 10 o'clock. Present A.W.Lucas, Ed.Baker, Cyrus S.Avery and Lewis Cline,County Clerk.

The claims were allowed, after which the following petitions were presented.

A petition was presented by the Tulsa County branch of the Oklahoma State Poultry Association for \$100.00 being appropriated for premiums to be used in payment of prizes for the Tulsa County Branch of the Poultry Association,according to an act of the 1916 legislature, house-bill No.510, requiring the County Commissioners to appropriate the sum of \$100.00. The Board ordered that the \$100.00 authorized on said act, be appropriated to the above association and expended under rules and regulations to be agreed upon by the County Commissioners thereof and the officers of the County Branch of the Oklahoma State Poultry Federation In Tulsa County. Motion carried.

Personally appeared before the County Commissioners of Tulsa County, a representative of the firm Tulsa Woven Wire Company, presenting to them a bid for the contract of the Dunbar School and the Sand Springs School. The cost of wiring was estimated at 21¢ per square foot, total amount of the Sand Springs School was \$101.60, and the total of the Dunbar School was \$88.00. The contract was awarded said firm, and orders were given to begin work immediately.

Resolution for the Sale of
Unused Lands.

It appearing to the Board of County Commissioners of Tulsa County,Oklahoma that Tulsa County is the owner of and has the possession of the following described real estate, situate in TulsaCounty, Oklahoma,to-wit:

Beginning at a point 1363.0 Ft.North of the S.W.Corner of Section 32, Township 20 N.Range 13 East,running thence East a distance of 901.25 ft.,thence North a distance of 944.3 ft., to the S,line of the Right of Way of the S.L. & S.F.R.R.,thence Southwesterly along the S.Line of the R of W. of the S.L.& S.F. R.R. a distance of 979.9 feet to the intersection with the W. line of Section 32, thence South a distance of 559.5 feet to place of beginning. Containing 15.55/100 acres, more or less.

And it further appearing that said parcel or tract of land is owned by Tulsa County, and is unused, and is ground that is not needed for courthouse or jail purposes, or for any other purposes by the County at this time;Therefore,

BE IT RESOLVED: By the Undersigned Board of County Commissioners that the same should be sold as prescribed by law ,as unused lands belonging to the County,not needed for courthouse or jail purposes by the County; and,

Be it further resolved that this Resolution be published as prescribed by law, and a copy of same be certified by the County Clerk to the Judge of the District Court of Tulsa County,Oklahoma. That said Judge be requested to appoint three disinterested householders of said County to appraise said real estate, and said appraisement to be returned by said appraisers to the Board of County Commissioners of Tulsa County,Oklahoma, for their further action.
