much of the highway as are designated and described in said petition as follows, to-wit:

Beginning at the intersection of the Broken Arrow Bixby Highway with a certain street or highway extending west along the center line of Claypool Subdivision, thence west along said street for a distance of approximately six hundred sixty feet (660') to the first street intersecting same; thence south along said street so intersecting for a distance of approximately four hundred (400) feet, all in Section 29, Township 19 North, Range 13 East, in Tulsa County, and State of Oklahoma.

AND, it further appearing from the said petition that said pipe line will be so constructed as not to interfere with any of the rights of the general public in the use of said highways and will be so constructed in accordance with all rules of the County Commissioners and the laws of the State of Oklahoma.

IT IS HEREBY ORDERED and adjudged by the Board of County Commissioners of said County, that permission be granted and the same is hereby granted to the said Chas. W. Wortman, his successors and assigns, to use for said purpose the highways above designated.

In the matter of laying a pipe line under, thru and across certain highways, the following order was made:

## ORDER

NOW, On this 21stday of September, 1931, the matter of the petition of W Manford Price for permission to lay a pipe line along, under and across certain highways in said County and State,, came up for hearing and it appearing to the Board and each of the Commissioners thereof, that it was and is just that the said W Manford Price be permitted to use as much of the highways as designated and described in said petition as follows, towit:

Beginning at the Broken Arrow-Bixby Highway at its intersection with a certain street or highway extending west along the center line of Claypool Subdivision, thence west along said street for a distance of approximately six hundred sixty (660') feet to the first street intersecting same; thence south for a distance of approximately four hundred (400) feet along said street so intersecting all in Section 29, Township 19 North, Range 13 East, in Tulsa County State of Oklahoma.

IT IS HEREBY ORDERED and adjudged by the Board of County Commissioners of said County that permission be granted and the same is hereby granted to W Manford Price, his successors and assigns to use for said purpose the highways above designated.

## RESOLUTION.

WHEREAS, the County of Tulsa is the owner of a number of pieces of property located in and about Collinsville, Oklahoma, which said property is either vacant or occupied by intruders, and

WHEREAS, it is deemed advisable to rent said property where possible, with a view to preserving same and securing such revenue as may be had therefrom, and it is necessary for such purpose to designate some proper person to act as agent for such properties.

NOW, THEREFORE, BE IT RESOLVED, that OWEN GARLINGHOUSE of Collinsville, Oklahoma is hereby designated as rental agent for the purposes above set forth, and he is hereby given authority to rent said property, such as may belong to Tulsa County, at such rents as he may deem propert the same to be rented from month to month, he to collect the rents, and in consideration for his services to retain one-half thereof, and pay the balance to the County Treasurer to be credited to the General Fund of said County, it being understood that if it becomes necessary to evict anyone from said property, or to bring legal action, that he first consult the County Attorney's office for such action as that office may deem advisable.

The foregoing agency being revocable at such time as the Board may deem advisable.

Moved, seconded and carried that the foregoing resoluton be approved and passed this 21st. day of September, 1931, and that the said Owen Garlinghouse be supplied with a certified copy of same as his authority to act in the same.
