done the auditing of his civil docket. For certain reasons we were compelled to postpone the Civil Audit, but be hope to be able to begin on it in a very short time.

NEW WORK.

I am arranging today to add to our force Mr. R. J. Moore for a short time and will assign him to the preliminary work in auditing Protested Tax Suits. As soon as the preliminary work has been completed we will then make a complete audit of each suit and report to you, and supply the County Attorney's Office with exact precise information concerning each case.

## ERRONEOUS ASSESSMENTS.

You will have presented to you today all of the remaining Erroneous assessment Applications with me recommendations. Also there will be presented to you the applications R. for erroneous assessment of H. Appleman and Anna/Appleman and the Livingston Oil Corporation.

These Assessments involve questions arising between the applicants and the County Treasurer in assessing and placing upon the Tax Rolls for various years, alleged omitted property. In order that the Board may act intelligently on these applications it will be necessary that all parties in interest appear before the Board.
