

Pole

Range 12 East, thence South 800 feet parallel to and near the west right of way line of said road.

AND, it appearing to the Board and each of the Commissioners thereof, that it was just and necessary that said application be granted, and it further appearing that said electric line will not interfere with any of the rights of the general public in the use of said highway, and that such electric pole line will be constructed in accordance with all lawful rules of the County Commissioners of Tulsa County, Oklahoma, and all laws of the State of Oklahoma governing same.

IT IS HEREBY ORDERED AND ADJUDGED by the Board of County Commissioners of said Tulsa County, Oklahoma, that such application be granted, and it is hereby granted to the Oklahoma Power and Water Co., and its assigns, to use as much of the highway as above designated for the purpose of constructing said electric pole line.
