RESOLUTION AND ORDER DIRECTING NOTICE BE GIVEN TO PAY CERTAIN ASSESSMENTS.

WHEREAS, in the report of Board of Viewers in and for Tulsa County Drainage District No. 12, heretofore filed herein, there was levied and assessed for costs or improvements in such Drainage District, certain amounts against Tulsa County, the City of Tulsa, and perhaps other municipalities within said Drainage District, various school and road districts lying within said District which amounts cannot be legally included in any bond issue anticipated or provided for.

NOW, THEREFORE, IT IS BY THE BOARD acting as Ex-Officio Commissioners for said Drainage District, hereby RESOLVED, ORDERED AND DIRECTED that the County Clerk proceed to give written notice to Tulsa County, City of Tulsa, Bbard of Education of School District No. 22, within said Drainage District and all road and other assessed districts or local governmental entities within such Drainage District of the sums and amounts assessed against it by Tulsa County Drainage District No. 12 for improvements purposes, that same may be paid as a whole on or before october 11th, 1943, without interest but that after said date same will bear 6% interest per annum thereafter; that same should be provided for as a valid claim in making up their annual budget hereafter until fully paid.

Thereupon, it was moved by Commissioner Greer, seconded by Commissioner Kinkaid, that said Resolution be adopted as read and a vote and roll call being had thereon, the Chairman declared same unanamously adopted.
