The State will construct, or cause to be constructed, to final completion said project in compliance with the plans and specifications which will include adequate inspection throughout the course of construction and in accordance with the laws of the State and the regulations of the State Highway Commission.

It is agreed that construction work on the project may be performed by contract or force account as may be found most advantageous to the County and State. Construction work that may be performed by force account will be charged to the County on the basis of the units of work performed at the unit prices set forth in the estimate as approved by the State Highway Engineer.
