The Board of County Commissioners met in regular session on Monday, October 4th, 1943, at the hour of 10:00 o'clock A.M., with all members present: J. B. Gray, Chairman; Curtis Greer and Robt. L. Kinkaid, members. Andy Stokes, County Clerk.

J. B. Gray, Chairman presiding, the following business was transacted.

Motion by Commissioner Kinkaid, seconded by Commissioner Greer, that the following Order be approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

ORDER OF BOARD OF COUNTY COMMISSIONERS RELATING
TO SALE OF COUNTY PROPERTY ACQUIRED AT RE-SALE

WHEREAS, the County Treasurer has presented to this Board the foregoing transcript of all his proceedings in said sale, with all papers and proofs relating to said sale, for the approval of this Board of County Commissioners, and

This Board of County Commissioners being convened in the office of the County Clerk of said County and State on the date hereinafter set forth.

WE HAVE CAREFULLY EXAMINED said transcript and proceedings, and find:

1. That the sale of Tract beginning 659.87' North and 294' East of SW corner of SW NW in Sec. 8, Twp. 19, Range 14, to L. M. Taylor for a consideration of \$25.00 was properly advertised and fairly conducted and the amount of the sale is deemed a fair price.

THEREFORE, so finding, the Board of County Commissioners of Tulsa County, State of Oklahoma, does hereby order and direct that the foregoing sale be approved; and the Chairman of said Board of County Commissioners is hereby ordered and directed to EXECUTE A DEED conveying the foregoing described property to L. M. Taylor in as full and complete a manner as the County is authorized to convey it; and the County Treasurer is ordered and directed, upon the execution of said deed to pay into the proper funds and accounts the moneys heretofore received in consideration thereof.
