WHEREAS, due notice has been given and published by the County Treasurer in the Sand Springs Leader, the official paper of the County of Tulsa, that the said County Treasurer would on this date apply to the Board of County Commissioners for an Order approving said sale, and directing the issuance of deed therefor; and

WHEREAS, pursuant to such notice, hearing on such sale has been had by the Board of County Commissioners and no other persons having appeared to bid a higher price for the purchase of said lots, and the County of Tulsa has no need for said lots for any purpose whatsoever.

NOW, THEREFORE, The Board of County Commissioners of the County of Tulsa, of the State of Oklahoma, in regular session assembled, and pursuant to the aforesaid statutes of Oklahoma, hereby approve the sale of said lands so made by the County Treasurer to Mattie H. Malone, for a consideration of Fourteen Hundred Thirty Two Dollars and Sixty Cents (\$1,432.60) and it is hereby ordered that the Chairman of the Board of County Commissioners execute to Mattie H. Malone, a deed conveying to her all the right, title and interest of the County of Tulsa, of the State of Oklahoma, in and to said lands and lots, and the County Clerk of Tulsa County is hereby directed to attest his signature and attach thereto the seal of his office.
