Motion was made and seconded that Petition as presented relative to sanitary conditions at the Tulsa County Farm be and the same is hereby referred to J P McLane; Supt.

Motion was made by Mr.North, seconded by Mr.Hedgecock, that the Petition filed by Citizens, asking for paved road from the Western terminus of the paved road west of West Tulsa along the south side of the Arkansas River be referred to the County Engineer with instructions to make preliminary investigation and report back to the Board of County Commissioners as soonas possible.
