MANAGEMENT CONFERENCE  
MARCH 9, 1995

The Board of County Commissioners of Tulsa County met at 9:30 a.m. with the following members present: John Selph, Chairman; Robert N. Dick, Lewis Harris. Members absent: none. Others present: Bill Thompson, Stanley Glanz, Jerry Griffin, Linda Webber, Dwain Midget, Denise Graham, Richard Bales, Linda Johnston, John Benjamin, Manny Gamallo and Melody Bishop.

Chairman called the meeting to order at 9:33 a.m. and the following business was transacted:

Chairman stated the purpose of the meeting is to have an open discussion of programs which have been suggested by various parties from the community to be a part of the election which the Board has called for June 13, 1995. The Board has until April 13 to decide what questions to present to the voters and deliver its resolution to the Election Board which includes the specific language of the ballot. At 10:00 a.m. on March 17, we will have a special management conference to hear the jail consultant's report about the size, cost and site of a new jail. The Jail Advisory Committee members are as follows: Sheriff Stanley Glanz, John Selph, David Moss, Judge David Winslow, Rodney Ray, Mayor Susan Savage and John Benjamin.

Dick stated that at today's meeting, the Board must determine what the requests are, what they are going to cost, and what would be acceptable to the voters of Tulsa County. The Board will hear from four groups who are asking for County funding for their respective programs, which they say will ultimately ease overcrowding at the jail.

Glanz presented information regarding the Sheriff's office budget and information on School Resource Officers (SRO). The total needed by the Sheriff's office for FY 95-96 is \$15,840,334. This includes new salaries to fully fund the D.A.R.E. program and Gangs units without outside grants, vehicles with a 4-year turnover, and court-house security provided through private security bids. Lt. Tim Albin presented the following: the projected costs to implement the SRO program would be \$3,417,466/year; the SRO program mission statement is to provide safe and secure environments for staff and students at schools through pro-active programs; there are approximately 98,500 students enrolled in public schools in Tulsa County; the average cost for the SRO would be \$34.69 per student per year, or two cents per day per student; it costs \$25 to incarcerate an inmate for one day. The SRO program would add 81 new positions to the Sheriff's staff.
