On and after this date we will not pay for any prescription issued by any doctor unless the indigent is now on the County rolls. This does not mean those who have reached the age of sixty-five and now receiving a pension from the State and Government.

The Legislature may assist us through a bill that is now before that body, but that is nothing definite, however, we want you to assist all indigents that are now on the County rolls by calling on them and administering the best way possible.
