MANAGEMENT CONFERENCE
 MAY 10, 1990

The Board of County Commissioners of Tulsa County met at the hour of 9:00 a.m., with the following members present: Melvin C. Rice, Chairman; Lewis Harris, John Selph. Members absent: none. Others present: Clayton Edwards, Nancy Cooper, Wayne Carr, Stanley Glanz, Marshall Stewart, Manny Gamallo, Dr. Jerry Griffith.

The Chairman called the meeting to order at 9:02 a.m., and the following business was transacted:

Sheriff Glanz was present to report on the jail population status. As to today, the population stands at 558, with an average population of 600. Presently the juvenile prisoners are averaging 10-11 daily, and women prisoners are averaging between 60 and 70. The Sheriff is presently negotiating with City of Tulsa officials on jail costs for the next fiscal year. The Sheriff has
