of the property described in the said application, placed thereon by the Tax Ferrit, for the years 1911, 1912, 1913 and 1914. Motion prevailed.

A motion was made by Ff M. Wooden and seconded by Geo. E. Gilmore that the Chairman of the Board of County Commissioners be authorized to sign the assignment of the lease of Brodie and Hughes, upon the fulfillment of the contract now held by Brodie and Hughes. Motion carried.

A motion was made by Geo. E. Gilmore and seconded by F. M. Wooden that the matter of the applications of H. Applemen and Anna Applemen, and J. K. Livingston for relief from erroneous assessments alleged to be made by the Tax Ferrit belaid over until April 5th, 1922, at the hour of 10 o'clock A. M. Motion carried.

A motion was made by F. M. Wooden and seconded by Geo. E. Gilmore that the Excise Board be requested to set aside an appropriation sufficient to purchase the 80 acres adjoining the county farm in the next supplemental appropriation, and that in the meantime the abstract be referred to the County Attorney. Motion carried.

Adjournment until 2 o'clock P.M.

The following resolution was introduced by Commissioner F. M. Wooden, who moved its adoption, and the motion to adopt was seconded by Geo. E. Gilmore, and the Chairman ordered the Esolution read.

RESOLUTION.

WHEREAS, TULSA COUNTY is the owner of certain personal property, to wit twelve mules, and certain equipment used in connection with said mules, and

whereas, the necessity for the further use of the said described personal property, and which also includes one Royal Standard 7 foot grading machine with extra cutting edge, certain plows and camping out fit has been removed, and

WHEREAS, it is to the best interest of the tax payers of TulsaCounty that said property be sold and disposed of, and

WHEREAS, there has been presented to the Board a proposition by John Cronin to purchase said property for a total consideration of \$2000.00.

THEREFORE, be it Resolved, in consideration of the above premises that the said proposition be accepted by the Board of County Commissioners and that the said property be sold to the said John Cronin for the sum of \$2000.00, that said sum is to be paid in equal installments of \$200.00 each monthly on the 25th day of each and every month beginning with the 25th day of March, 1922.

AND BE IT FURTHER RESOLVED, that the title to the said personal property shall remain in Tulsa County until the full payment has been made.

AND BE IT FURTHER RESOLVED THAT THE Chairman of this Board be and he is hereby authorized on behalf of the Board of County Commissioners to enter into an agreement and conditional bill of sale in writing with the said John Cronin, in accordance with the terms of this resolution. All members present voting in the affirmative the resolution was by the chairman ordered spread of record.

The agreement and conditional bill of sale, is as follows, to-wit:



"AN AGREEMTNT AND CONDITIONAL BILL OF SALE.

THIS AGREEMENT, made by and between TULSA COUNTY, State of Oklahoma, through the Board of County Commissioners thereof, parties of the first part, and J. W. Cronin, party of the second part, WITNESSETH:

Party of the first part, being the owner of Six (6) mule teams, described as follows:
