

provided among other things: Said board shall have authority and power, under the provision of this act to provide for the erection and repairing of Court houses.

As all power is implied which is necessary to give force to that which is expressly granted. It follows that in providing for the erection of a court house, the board has a right to select a site upon which to erect it, and that when it does this it is merely performing an administrative duty, and one that is in no sense legislative.

It therefore for the reasons expressed above that your action in locating the court house is final, and that it cannot be questioned under the referendum.
