### R E S O L U T I O N .

WHEREAS, one Athel Dickey, charged with seduction, is a fugitive from justice from the State of Oklahoma and is now in the United States Navy attached to the U.S.S. Seattle, now stationed at Bremerton, Washington, and

WHEREAS, it is necessary that requisition be made upon the Secretary of the Navy for the delivery of said person to the authorities of Tulsa County for trial upon said charge, and

WHEREAS, in order to secure said requisition it is necessary that the County of Tulsa obligate itself to return the said Athel Dickey to the naval authorities at point of delivery, if so required after the conclusion of his trial without expense to the United States.

NOW, THEREFORE, BE IT RESOLVED, that the County Attorney of Tulsa County, Oklahoma, be and he is hereby authorized and directed to make requisition upon the Secretary of the Navy for the return of the said Athel Dickey, and that all necessary expenditures in and about securing the delivery and return of said Athel Dickey to Tulsa County, Oklahoma be and the same are hereby authorized; and be it further resolved that the Board of County Commissioners aforesaid acting by, for and on behalf of the County of Tulsa, State of Oklahoma, do hereby bind and obligate said County of Tulsa, State of Oklahoma, aforesaid, that the Secretary of the Navy will be informed of the outcome of the trial of said Athel Dickey, and that the said Athel Dickey will be returned to the naval authorities at the place of his delivery to the civil authorities, if so required, without expense to the United States immediately upon the completion of his trial upon said charge in the event of his acquittal thereof or immediately upon satisfying the sentence of a Court of competent jurisdiction in the event that he is convicted and a sentence imposed or upon other final disposition of his case.
