That the assessments hereby levied against the several tracts, lots and parcels of land shall bear interest from the date hereof, at the rate of six per cent (6%) per annum until paid, and the assessments shall be payable in twenty (20) equal annual installments. The firstof such installments, with interest on the whole assessment, shall be payable on or before the first day of September, 1929, and the succeeding annual installments with interest on the whole amount remaining unpaid, respectively, shall be payable on or before September 1st. of each of the next succeeding years, provided, however, that the owners of the property hereby assessed shall have the privilege of paying the amounts of the respective assessments without interest within thirty days from the date of the publication of this Resolution, which publication is hereby directed to be made on the 28th, day of May, 1929, in the Tulsa Tribune, a newspaper printed and published in the City of Tulsa, Oklahoma.
