BE IT FURTHER RESOLVED, That this Resolution be published as prescribed by law, and a copy of the same be certified to the County Clerk to the Judge of the District Court of Tulsa County, Oklahoma, and that said Judge be requested to appoint three disinterested householders of said County to appraise said real estate, and said appraisal to be returned by said appraisers to the Board of County Commissioners of Tulsa County, Oklahoma, for their further action.

WHEREAS, The Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance to Henry W Kiel of a deed conveying to him for a consideration of Three and 99/100 (\$3.99) the following described lot:
