Ormsby and others, re: the organization of a water improvement district, be heard on the 10th day of September, 1945, at the hour of 10:00 o'clock a. m., be and the same hereby is rescinded; and that hearing on said peition be set for the 1st day of October, 1945, at the hour of 10:00 o'clock a. m., and that a meeting of the Board of County Commissioners be held for that purpose at that time and the County Clerk give notive thereof, by publishing the notice at least wice in a newspaper printed in Tulsa County and of general circulation in the territory affected, the first notice shall be published ten days before said hearing. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Bailey, that the following Resolution be approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

RESOLUTION OF THE BOARD OF DIRECTORS OF WATER IMPROVEMENT DISTRICT NO. 5 OF TULSA COUNTY, OKLAHOMA, REQUESTING THE COUNTY COMMISSIONERS OF TULSA COUNTY, OKLAHOMA, TO CALL IN AND PAY BONDS NUMBERES 147-148-149 of SAID DISTRICT.

WHEREAS: There is now on deposit in Sinking Fund Account of Water Improvement District No. 5 of Tulsa County, Oklahoma, in the hands of the County Treasurer of Tulsa County, Oklahoma, after payment of all interest due on the bond issue before the maturity date of the next installment of said assessment, levied to create a fund with which to pay said bonds, sufficient to constitute a surplus over and above the necessary requirements of said fund and to pay the principal and interest on bonds numbered 147-148-149 to October 1, 1945. These bonds are being retired in numerical order as required by the Statute.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the bond filed by Catherine Fiorella, in the amount of \$1,000.00 and made by the Maryland Casualty Company, be and the same is hereby approved.
