

MONDAY, JULY 11, 1949

Accumulative Supplement, 1947, I therefore move that the Excise Board be, and it is hereby requested to approve Twenty-five (25%) per cent of all Budget Requests as filed, and that the County Clerk be hereby authorized and directed to submit a Certified Copy of this motion to the Excise Board for their approval.
