MONDAY, MARCH 13th, 1939.

Pursuant to recess heretofore taken, the Board of County Commissioners re-convened at the hour of 9:30 o'clock A.M., with all members present: John H. Miller, Chairman; J. B. Gray and Harry L. Hopkins, members. Andy Stokes, County Clerk.

John H. Miller, Chairman presiding, the following business was transacted.

Reading of the minutes of the previous meeting was dispensed with and there being no objection to the same they were ordered to stand approved.

John H. Miller, Chairman, deposited on March 7th, 1939, with the County Treasurer \$6.00 collected from Mrs. Gwin for gas, water and electricity in connection with the lunch counter in the basement. Same was ordered filed. Receipt #18398.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that the Abstractor's bond filed by the Guaranty Abstract Company made by the National Surety Corporation in the amount of \$5,000, be and the same is hereby approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that the Justice Quarterly report filed by J. B. Sample, Justice of the Peace, be and the same is hereby accepted and filed. Motion roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that the following Authority to Release Securities be approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

#### AUTHORITY TO RELEASE SECURITIES

We, the undersigned Board of County Commissioners of Tulsa County, Oklahoma, being in legal meeting convened, have given due consideration to the demand of the First National Bank of Broken Arrow, Oklahoma, and authorized depository of said County, and the verification of the accounts of said County with said depository Bank as made by the County Treasurer herein, and we find such withdrawal will leave the accounts of the County adequately secured within the sum of \$10,500.00; and therefore we do hereby direct and command that the specific securities identified by the within and foregoing detailed list in the aggregate sum of \$13,000.00 be released by the County Treasurer and the Custodian of said securities to the Owner Bank herein or on his order, immediately and without delay.
