LEASE

THIS LEASE, Made this the 12th. day of October, 1931, by and between the Board of County Commissioners, party of the first part, and HUBERT CRADDOCK, party of the second part:

WITNESSETH: That said first party in consideration of the covenants and agreements hereinafter set forth do by these presents demise, lease and let unto the second party the ground located in the center of the County Highway at the Southwest Corner of Sec. 7, Twp 17, Range 13, Glenn Pool Township, situated in the County of Tulsa, State of Oklahoma, now known as Hilltop Service Station, for the purpose of running a filling station.

TO HAVE AND TO HOLD the same to the second party from the 20th. day of October 1931 to the 20th. day of October, 1932. And said seconde party, in consideration of the premises herein set forth, agrees to pay to the First Party, as rental for the above described ground the sum of Sixty (\$60.00) Dollars per year, in advance.
