Foley in exchange for the said 1940 1-1/2 Ton Pickup, Ford V-8 when accompanied by a proper transfer of title to Tulsa County and that the County Highway Department be authorized to draw a claim to Harry A. Foley in the sum of Five Hundred Dollars (\$500.00), payable from Account Number 8, designated as "Purchase of Tools, Trucks & Equipment" of the County Highway Department of the _____ Fund.
