## RESOLUTION.

WHEREAS, It is essential that the maintenance and tip-keep of the highways of Tulsa County be not neglected, and

WHEREAS, the employees engaged in maintenance of the County Highways and Township Roads and Bridges are expected to properly and thoroughly maintain the said highways and bridges, and

WHEREAS, there being a lapse of time between June 30th, and the date when final appropriations are made to provide funds for such maintenance and up-keep. And,

WHEREAS, it is provided by law that Townships may make a 2 mill levy for road maintenance, and a  $1-\frac{1}{2}$  mill levy for construction purposes, and

WHEREAS, it is provided by law that funds derived by Automobile License Collections, etc. County Road Funds of all character shall go into the County Highway Fund.

NOW, THEREFORE, BE IT RESCLVED, That the County Engineer be directed to keep in proper state of maintenance; to care for emergencies that may arise, etc. the County and Township Highways in Tulsa County, and to issue claims in payment for actual and necessary work to care for such maintenance and other emergencies; to pay salaries for engineer9ng, inspection, patrol maintenance etc., by issuing and approving claims for suchverified service, against the anticipated funds to be provided for the Fiscal Year 1924-25, as a County Highway Fund and out of the anticipated funds of the Sever al Townships in Tulsa County.
