Also, beginning at the entrance to the County Fair Grounds on the South line of Section 9, Township 19 North, Range 13 East, and following north along the most advantageous line to 15th. Street; thence West along 15th. Street to Harvard Avenue.

And, Be It Further Resolved, That the County Engineer be instructed to immediately prepare plans and specifications and to advertise for bids for the paving from Harvard Avenue, East to entrance to Fair Grounds, and to take appropriate action to grade and oil, or otherwise improve the last above designation.
