R E S O L U T I O N

WHEREAS, the law of this State pertaining to the acquiring of automobile license tags provides that said license tags must be procured not later than January 1, 1927.

AND, WHEREAS, there are numerous cars upon the streets of the City of Tulsa, and the Highways of this County displaying license tags of this and foreign States for the year 1926, and prior thereto, to the end therefore, that the law may be complied with both as to "the auto licanse tags" of this and foreign States.

BE IT RESOLVED, that the Sheriff and Highway Police be instructed to co-operate in making a "check up" of all of such cars and automobiles as aforesaid, and warn the owners thereof to procure license tags therefor forthwith and make report of their investigations to the County Clerk of this County.

BE IT FURTHER RESOLVED that a certified copy of this Resolution be transmitted the City Commissioners of the City of Tulsa respectfully requesting the co-operation of the Police Department in the matter.
